CMS recently announced the awards for the national Hospital Quality Improvement Contract (HQIC), targeting small and rural hospitals, and facilities that serve vulnerable populations. Your facility is one of more than 2,400 hospitals nationwide that CMS identified for participation in HQIC, which is being offered at no cost to participating hospitals. The Louisiana Hospital Association's Research and Education Foundation (LHAREF) believes your hospital would benefit from, and be successful in, this four-year program. The focus of HQIC is to reduce patient harm, address the opioid epidemic, improve behavioral health outcomes and improve care transitions for our patients and communities. This program will also support hospitals in responding to public health emergencies, like COVID-19, to ensure safe care and to facilitate preparedness for future public health crises.

# Your state partner and the HQIC national team will provide at no cost:

- Technical assistance and coaching on quality improvement; culture change; patient and family engagement; and data submission, interpretation, analysis and more.
- Clinical topic-specific resources and peer-to-peer resources including up-to-date checklists, discovery tools, change packages and case studies.
- Peer-to-peer networking and sharing at virtual training events.
- Access to virtual, on-demand learning modules.
- Best practice hospital stories and case studies, which highlight specific topics and provide detailed information on successes and lessons learned.

#### **How Can Your Hospital Participate?**

- Commit! Have your CEO and quality lead co-sign the letter of commitment.
- Submit data. Collect and submit monthly data on commonly-reported, nationally-standardized quality measures. CMS has not yet released the formal measure set, but data will be obtained from NHSN, claims and selfreporting.
- Engage and share:
  - Engage with subject-matter experts, and share your improvement stories with peers.
  - Prepare for, and participate in, virtual site visits to help hospital employees learn about barriers and other issues affecting your hospital.
  - Support changes within your facility by utilizing crosscutting improvement strategies to improve patient
